<u>Gist of the Proceedings of the 25th Annual General Meeting of</u> <u>Edelweiss Financial Services Limited held on Monday, September 28, 2020</u>

The 25th Annual General Meeting ('AGM') of the Members of the Company was held on September 28, 2020 at 4.00 p.m. (IST) through Video Conferencing/ Other Audio Visual Means(VC/OAVM) in compliance with the General Circulars No. 20/2020 dated May 5, 2020, read with Circulars dated April 8, 2020 and April 13, 2020 issued by the Ministry of Corporate Affairs (MCA) and in accordance with the Circular dated May 12, 2020 issued by the Securities and Exchange Board of India (SEBI)("the Circulars).

The Meeting was chaired by Mr. Rashesh Shah, Chairman, Managing Director & CEO of the Company. All the members of Board of Directors were present in the Meeting. The Statutory Auditors and the Secretarial Auditors of the Company were also present.

The requisite quorum being present, the Chairman called the meeting to order.
