Scrutinizer's Report on e-voting conducted pursuant to Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the "Listing Regulations") and pursuant to the provisions of Sections 108 and 110 of the Companies Act, 2013 (the "Act") read with the Rules and the Circulars issued by the Ministry of Corporate Affairs, thereof, the manner of voting on the proposed Resolutions being restricted only to remote e-voting ("e-voting").

#### Appointment as Scrutinizer for Postal Ballot through e-Voting 1.

We were appointed as the Scrutinizer for the Postal Ballot Notice dated May 14, 2025, (through remote e-voting) by the Board of Directors of Edelweiss Financial Services Limited (hereinafter referred to as the "Company").

The Company had hosted the said Notice on its website, website of NSDL and were also submitted to the Stock Exchanges i.e. BSE Limited and the National Stock Exchange of India Limited on June 06, 2025.

The Company had also published the Notice on June 07, 2025, in Financial Express (English Newspaper) and Nav Shakti (Marathi Newspaper), having electronic editions, specifying the date of commencement and conclusion of the Postal Ballot through e-voting process.
