#### CLARIFICATION ON RECENT REPORTS IN THE MEDIA REGARDING EDELWEISS

**Mumbai, August 27, 2025** – Edelweiss Financial Services Limited ("EFSL") wishes to set the record straight on a misleading article published by NDTV Profit and certain other media platforms on August 26, 2025.

The original article incorrectly stated that Mr. Rashesh Shah, Promoter of EFSL, had sold shares in the Company. Mr. Shah has not sold any shares.

#### Correct facts:

- The block transaction was executed by the Edelweiss Employee Welfare Trust (EWT) in compliance with regulations.
- The shares were acquired by Abakkus Asset Manager Pvt. Ltd., an asset management firm.

Notably, the publications in question did not verify facts with Edelweiss before publishing the original misleading articles.
