"Given the complexity of issues today, it is extremely critical for corporates across India to look at philanthropy through a strategic lens," said Shah.

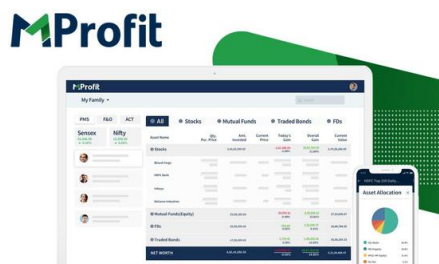

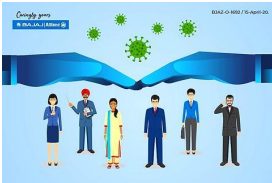
